#### Nomination Process

Any orthodontic department in the United States can nominate a current student for the award. An individual student can be nominated only once. The department will submit a letter of recommendation from the student’s faculty adviser or other faculty member; an additional letter of recommendation from any other source; and an application form.

All application materials must be submitted in digital format by 4 p.m. MST, Friday, November 3, 2023, by the orthodontic department. Each applicant will receive records of an unpublished case on November 6, 2023, and must submit a complete treatment plan by November 20, 2023, at 4 p.m. MST.

#### Judging and Finalists

A panel of three editors, moderated by Editor Neal Kravitz, will review all applications and select 12 finalists. All 12 finalists will be profiled on the JCO Facebook page. Finalists must submit all relevant materials from a case—finished or unfinished—worked on by the finalist. If the finalist did not do all of the work on the case, please note which parts were done by the finalist. The case should be submitted in the same style as an ABO submission, including the written case report, discrepancy index, cast-radiograph evaluation, any digital records, and progress photos showing the appliances on the teeth. All materials must be submitted in digital format by 4 p.m. MST, Friday, January 19, 2024.

A wider panel of JCO editors will evaluate the finalists’ application materials. The winner will be the student who displays the

highest clinical aptitude and the most well-rounded approach to orthodontics and life. The winner will be announced on March 13, 2024, will receive the prize package at the AAO convention in New Orleans, and will have his or her profile published in a future issue of JCO.

The winner will receive a two-year print subscription, \$8,245 worth of orthodontic products and services from American Orthodontics (AO) and Dolphin, and all travel expenses to both the 2024 AAO Convention in New Orleans and the American Orthodontics annual resident summit in Sheboygan, WI, in June 2024.
